MINUTES

The Bossier Parish Police Jury met in regular and legal session on this 19th day of October, 2005, at 2:00 p.m., in the Police Jury Meeting Room, Bossier Parish Courthouse, Benton, Louisiana. The President, Mr. Jeff Rogers, called the meeting to order. The invocation was given by Mr. Eddy Shell and the pledge of allegiance was led by Mr. Jimmy Cochran. The Secretary-Treasurer, Ms. Cheryl Martin, called the roll, with all members present, as follows:

Others present were Mr. Bill Altimus, Parish Administrator; Mr. Patrick Jackson, Parish Attorney, Mr. Joe E. "Butch" Ford, Jr., Parish Engineer; Ms. Cheryl Martin, Secretary-Treasurer.

Motion was made by Mr. Shell, seconded by Mr. Darby, to adopt the minutes of the September 7, 2005 regular meeting, as published. Motion carried unanimously.

Motion was made by Mr. Avery, seconded by Mr. Cummings, to adopt the minutes of the September 21, 2005 regular meeting, as published. Motion carried unanimously.

Mr. Kenneth Starnes, Section 8 Housing Director, requested approval of the Annual Agency Plan for the Bossier Parish Section 8 Housing Program, advising that the plan includes two changes. Mr. Starnes stated that any housing documents which expire on a weekend date will now be extended until 4:30 p.m. on the next business or working day. He stated that the new plan provides a preference list for evacuees of Hurricane Katrina. Mr. Starnes stated that HUD has developed a new housing assistance program for evacuees of Hurricane Katrina, and that the new plan provides a preference list for those persons. **Motion was made by Mr. Hammack, seconded by Mr. Altimus, to adopt the Annual Agency Plan for the Bossier Parish Section 8 Housing Program, as presented. Motion carried unanimously.**

Mr. Linc Coleman, Northwest Louisiana Board of Realtors, and Ms. Virginia Shehee, discussed a proposal to utilize the Urban Land Institute's Advisory Services 5-Day On-Site Panel Study for the purpose of identifying land issues in an effort to enhance economic development in the Shreveport/Bossier City metropolitan area. The total cost for the proposed study is \$125,000 and it is requested that the police jury contribute \$12,500. Mr. Coleman stated that the five-day panel involves a team of eight to ten members who work together on site to investigate market potential and develop planning and design strategies to maximize an area's potential.

Mr. Altimus referred to the recent creation and adoption of a Comprehensive Land Use and Development Plan for Bossier City and the area within the five mile jurisdiction of the Bossier City-Parish MPC, and asked if this proposal will duplicate any of the information provided in the land use plan. Mr. Sam Marsiglia, Bossier City-Parish MPC, stated that he feels the proposed study will complement the existing plan.

Motion was made by Mr. Cummings, seconded by Mr. Mitchell, to consider the request for \$12,500 during 2006 budget hearings. Mr. Altimus offered an amendment to the motion, seconded by Mr. Mitchell, to approve the request for funding now. Motion, as amended, carried unanimously.

Sealed bids were opened and read aloud for the purchase of a PC public computer time management/reservation system for the Bossier Parish Library. Mr. Louis Covington, Bossier Parish Library Director, opened bids as follows:

Mr. Covington advised that this is the only bid received, and that it is within the amount budgeted for the purchase. He recommended that the bid of The Library Corporation be accepted. **Motion was made by Mr. Avery, seconded by Mr. Mitchell, to accept the bid of The Library Corporation for the purchase of a PC public computer time management/reservation system for the Bossier Parish Library. Motion carried unanimously.**

Ms. Martin announced the continuation of a public hearing held on October 5, 2005, to consider an amendment to the Unified Development Code to reflect changes pertaining to the placement of modular homes. Mr. Altimus stated that Mr. Greg Tilley, Tilley's Bossier Mobile Homes, has recommended a change to the proposed ordinance regarding the required roof pitch. He stated that Mr. Tilley has recommended that a minimum 6/12 roof pitch be required. Mr. Avery stated that the roof pitch should comply with the requirements of the restrictive covenants in areas where such covenants are in place.

Ms. Martha Reyenga discussed the placement of a modular home within an area where such homes are prohibited by the restrictive covenants, asking who is responsible for preventing a modular home from being placed in these areas. Mr. Jackson, Parish Attorney, stated that the police jury has no jurisdiction in the enforcement of restrictive covenants. Mr. Sam Marsiglia, Bossier City-Parish MPC, stated that in the initial permitting process, he needs to be made aware of the proposed location of a modular home so that the site can be inspected to determine if all regulations are met.

It was recommended that an administrative policy addressing this issue be established.

Motion was made by Mr. Cochran, seconded by Mr. Hammack, to adopt an ordinance amending the Unified Development Code to add regulations pertaining to the placement of modular homes within the five mile jurisdiction of the Bossier City-Parish MPC, as written. Motion carried unanimously.

ORDINANCE NO. 4065

AN ORDINANCE TO AMEND BOSSIER PARISH ORDINANCE NO. 3908 OF 2003 WHICH ADOPTED A UNIFIED DEVELOPMENT CODE FOR THE BOSSIER CITY-PARISH METROPOLITAN PLANNING COMMISSION AND THE PARISH OF BOSSIER, LOUISIANA, TO REFLECT CHANGES RELATIVE TO THE DEFINITION AND PLACEMENT OF MODULAR HOMES.

BE IT ORDAINED, that the following Sections in the Unified Development Code are added or amended to read as follows:

Section 5.6.1

Subsection C. Within the jurisdiction of the Bossier MPC placement of a Modular Home, as defined in Section 18.2.55, on a tract of land zoned R-E, R-LD or R-MD or on property within 300' of the zoned tracts, will require approval by the Board of Adjustment following a public hearing in accordance with the procedures of Section 3.3.3. Measurement shall be made in a straight line, without regard to intervening structures or objects, from the nearest property line of the tract where a modular home is to be located to the nearest property line of the residentially zoned tract.

Paragraph 1 The modular home shall be designed to blend in with the neighboring residences. For example:
 a) Roof pitches shall be of similar pitch to the average pitch of the neighboring residences.
 b) Proportions and composition of the modular home shall be comparable to those of the existing neighboring residences.
 c) The modular home shall be erected on a permanent foundation system the same as the majority of the neighboring residences.

Section 18.2.55

Subsection A. A dwelling unit composed of individual, pre-constructed sections that are built at an off-premise facility, transportable in one or more sections, not constructed on a permanent chassis, placed on a permanent foundation, and assembled for permanent residential use. The structure is attached to the foundation without the chassis, towing hitch, brakes, axles, wheels and other parts of the chassis that only operate during transportation.

Subsection B. To qualify for this definition, a modular home must be fabricated in a factory whose products are certified to meet all requirements of the Louisiana State Uniform Construction Code. In addition, all modular homes utilizing Bossier City utilities must meet the additional requirement of using copper plumbing for water lines inside the modular home.

BE IT FURTHER ORDAINED, that in Section 5.3, "Single Family, detached – Modular" is added to the Use Table as a "Provisional Use" in the R-A; Residential Agriculture District and as a "Special Exception Use" in the RE; Residential Estate District, R-LD; Residential Low Density District and in the R-MD; Residential Medium Density District.

The ordinance was offered by Mr. Cochran, seconded by Mr. Hammack. Upon unanimous vote, it was duly adopted on this 19th day of October, 2005.

Mr. Altimus provided copies of a resume from Mr. Robert Wynn, advising that Mr. Wynn is interested in serving on the Bossier Parish Library Board of Control to fill the expiring term of Mr. Mike Montgomery. **Motion was made by Mr. Hammack, seconded by Mr. Williams, to approve the appointment of Mr. Robert Wynn to the Bossier Parish Library Board of Control, replacing Mr. Mike Montgomery. Motion carried unanimously.** Mr. Wynn's appointment is for a five-year term which expires October, 2010.

Mr. Jackson, Parish Attorney, advised that a petition has been received signed by residents of Riverbend Road, who are in favor of the police jury accepting the remaining portion of Riverbend Road into the parish road maintenance system. He stated that the estimated cost for expropriation of the required right-of-way is approximately \$50,000, which includes appraisal fees and other related expenses. Riverbend Road is a private road owned by Mr. Terry Shelton.

Mr. David Cummings spoke on behalf of Mr. E. R. Burkhalter, owner of Finish Line Stable, 1105 Riverbend Road, advising that if Mr. Shelton is allowed to close Riverbend Road, it will adversely affect the business and its employees. He stated that it would create a hardship on families living on Riverbend Road and would prevent school buses and emergency service vehicles from accessing the road.

Mr. Alan Fox requested that the police jury proceed with the acceptance of Riverbend Road into the parish road system, advising that it will benefit all the residents living along the road.

Motion was made by Mr. Cochran, seconded by Mr. Hammack, to authorize the Parish Attorney to initiate procedures for the expropriation of right-of-way along a portion of Riverbend Road.

There was discussion on the motion. Mr. Terry Shelton addressed the jury, advising that he has never closed the gate on Riverbend Road. He stated that he is considering an offer from a buyer who wants to purchase the road.

Votes were cast on Mr. Cochran's motion to proceed with expropriation of right-of-way along Riverbend Road. Motion failed due to a tie vote, as follows:

AYES: Mr. Cochran, Mr. Darby, Mr. Hammack, Mr. Johnston, Mr. Meachum, Mr. Williams.

NAYS: Mr. Altimus, Mr. Avery, Mr. Cummings, Mr. Mitchell, Mr. Rogers, Mr. Shell.

ABSTAIN: None

ABSENT: None

Mr. Rowdy Prince stated that he can access his property on Riverbend Road via the Bodcau Station Road. He urged the jury to reconsider this issue, advising that many people use Riverbend Road. Mr. Avery requested that the matter be reviewed in 90 days.

Motion was made by Mr. Altimus, seconded by Mr. Shell, to adopt the Annual Certification of Compliance with the Louisiana Off-System Bridge Replacement Program. Motion carried unanimously.

RESOLUTION

ANNUAL CERTIFICATION OF COMPLIANCE WITH THE STATE OF LOUISIANA OFF-SYSTEM BRIDGE REPLACEMENT PROGRAM.

WHEREAS, the code of Federal Regulation, as enacted by the United States Congress, mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity and posted in accordance with the National Bridge Inspection Standards and that an inventory of these bridges be maintained by each State; and

WHEREAS, responsibility to inspect, rate and load post those bridges under the authority of Bossier Parish in accordance with those Standards is delegated by the Louisiana Department of Transportation and Development to Bossier Parish.

NOW THEREFORE, BE IT RESOLVED that the governing authority of Bossier Parish in regular meeting assembled does hereby certify to the Louisiana Department of Transportation and Development (herein referred to as DOTD) that for the period October 1, 2005 through September 30, 2006:

1. The Parish has performed all interim inspections on all parish owned or maintained bridges in accordance with the National Bridge Inspection Standards.
2. All bridges owned or maintained by the Parish have been structurally analyzed and rated by the parish as to the safe load capacity in accordance with AASHTO Manual for Maintenance Inspection of Bridges. The load posting information that has been determined by the Louisiana DOTD for all bridges where the maximum legal load under Louisiana state law exceeds the load permitted under the operating rating as determined above has been critically reviewed by the Parish. Load posting information has been updated by the Parish to reflect all structural changes, any obsolete structural ratings or any missing structural ratings.
3. All Parish owned or maintained bridges which require load posting or closing are load posted or closed in accordance with the table in the DOTD Engineering Directives and Standards Manual Directive No. 1.1.1.8. All DOTD supplied load posting information concerning a bridge has been critically reviewed by the Parish Engineer prior to load posting.
4. All bridges owned or maintained by the Parish are shown on the attached list in the format specified by the DOTD. Corrections to data supplied to the Parish by LA DOTD are noted.

These stipulations are prerequisites to participation by the Parish in the Off-System Bridge Replacement Program.

This resolution was considered section by section and as a whole. Upon motion by Mr. Altimus, second by Mr. Shell and vote, it was duly adopted on this 19th day of October, 2005.

ORDINANCE NO. 4066

AN ORDINANCE TO OFFICIALLY POST CERTAIN BRIDGE STRUCTURES LOCATED ALONG THE PARISH TRANSPORTATION SYSTEM IN THE PARISH OF BOSSIER, STATE OF LOUISIANA.

WHEREAS, the Bossier Parish Police Jury is responsible for health, safety and welfare of the public utilizing the parish transportation system in Bossier Parish, and the bridge structures located on these transportation routes; and

WHEREAS, the Bossier Parish Police Jury, in order to provide advance information regarding the bridge structures located on its parish transportation routes, has structurally rated and posted certain bridges, as required by federal, state and local laws.

NOW, THEREFORE, BE IT ORDAINED by the Bossier Parish Police Jury that the bridge structures listed below by structure number and location are hereby officially posted by signing to provide sufficient advance notice to the motoring public as to the load carrying capabilities of each structure:

Mr. David Rockett, Greater Bossier Economic Development Foundation, discussed the request of the Coordinating and Development Corporation to purchase 2.637 acres in the Viking Drive Industrial Park, advising that the additional acreage requested is included in the Master Plan. Mr. Altimus stated that he has verified that a specific manufacturing project is proposed for this tract. **Motion was made by Mr. Altimus, seconded by Mr. Johnston, to approve the sale of 2.637 acres in the Viking Drive Industrial Park to the Coordinating and Development Corporation DBA Ark-La-Tex Investment and Development Corporation for a price of \$12,000 per acre, and to authorize the President to execute said act of sale. Further noted in the motion, if the property is not used for a manufacturing/warehouse type business within six months, ownership of the property will revert back to the police jury. Motion carried unanimously.**

RESOLUTION

BE IT RESOLVED by the Bossier Parish Police Jury in regular and legal session convened on this 19th day of October, 2005, that it does hereby approve the sale of 2.637 acres in the Viking Drive Industrial Park to The Coordinating and Development Corporation DBA Ark-La-Tex Investment and Development Corporation, for a price of \$12,000 per acre, and does authorize Jeff Rogers, President, to execute any necessary documents in connection with the sale, said property being described as follow:

A portion of Lot 6, Viking Drive Industrial Park, as recorded in Conveyance Book 1207, Page 666 of the Records of Bossier Parish, Louisiana, and being more fully described as follows: Beginning at the northwest corner of said Lot 6, run thence along the northerly property line of said Lot 6 South 89° 01' 30" East a distance of 489.27 feet to a point on the westerly right of way line of Marlena Street; Thence leaving said northerly property line run along said westerly right of way line South 33° 23' 02" West a distance of 213.37 feet to the point of curvature of a curve to the left (said curve having a radius of 240.00 feet and a chord bearing South 20° 07' 04" West a distance of 110.15 feet); Run thence along said curve and westerly right of way line an arc distance of 111.14 feet; thence leaving said westerly right of way line run West a distance of 334.75 feet to a point on the westerly property line of said Lot 6; Run thence along said westerly property line North 00° 09' 56" east a distance of 289.92 feet to the Point of Beginning of tract, containing 2.637 acres, more or less.

The resolution was offered by Mr. Shell, seconded by Mr. Mitchell. Upon vote, it was duly adopted on this 19th day of October, 2005.

Mr. Altimus reported that a preconstruction meeting on the new Benton Library project will be held in the police jury office at 9:00 a.m. on October 25, 2005. He stated that a groundbreaking ceremony for the facility will be held on site at 1:00 p.m., October 27, 2005.

Motion was made by Mr. Altimus, seconded by Mr. Hammack, to declare adjudicated property at Lot 9, Almond Subdivision, 1008 Burchett, Bossier City, LA, as surplus, to be advertised for bids for the sale of said property. Motion carried unanimously. Mr. Altimus stated that parish taxes in the amount of \$3072.23 are owed on the property and he will obtain taxes owed the City of Bossier City, to be included in the minimum acceptable bid.

Mr. Altimus reported that there was a large turnout at a meeting hosted by Mr. Richie Jackson, Bossier Parish Truancy Program, in connection with the formation of a Youth Services Planning Board for the 26th Judicial District, in accordance with Act 555 of the Louisiana Legislature.

Mr. Ford presented Plan Change No. 3 on the Airline Drive Five-Lane Expansion Project in a net additional amount of approximately \$132,000. He stated that a portion of the additional costs in this plan change are the result of work done in the cross slope correction of the existing road. **Motion was made by Mr. Williams, seconded by Mr. Avery, to approve Plan Change No. 3 on the Airline Drive Five-Lane Expansion Project in a net additional amount of \$132,103.51. Motion carried unanimously.**

Mr. Ford stated that traffic signals on Airline Drive should be installed within two weeks. He stated that only three lanes of Airline Drive will remain open until these lights are operational.

Motion was made by Mr. Mitchell, seconded by Mr. Williams, to approve a Plan Change on the Bossier Health Unit renovation project in an additional amount of \$3,233.65. Motion carried unanimously.

Motion was made by Mr. Johnston, seconded by Mr. Mitchell, to schedule a public hearing on November 16, 2005, to consider approval of the plat of the proposed development of Big Oaks Estates, located in Section 18, Township 19 North, Range 11 West, Bossier Parish, LA. Motion carried unanimously.

Mr. Niall Whatley and Mr. Ronnie Duvall, Alliance, Inc., were present regarding the courthouse renovation/addition project. Mr. Ford stated that the 690 calendar days allotted for Phase One and Phase Two of the courthouse project ended on October 13, 2005, and that liquidated damages should apply from that date. He stated that Walton Construction has indicated a move in date of December 4, 2005. Mr. Jackson, Parish Attorney, stated possible Fire Marshal delays must also be considered.

A meeting of the budget committee is scheduled at 6:30 p.m., Monday, October 24, 2005, at Gators restaurant for review of the proposed 2006 Bossier Parish Police Jury budget.

Motion was made by Mr. Meachum, seconded by Mr. Cochran, to establish a 35 mile per hour speed limit on Atkins Clark Road. Motion carried unanimously.

ORDINANCE NO. 4067

AN ORDINANCE REGULATING THE SPEED OF VEHICLES ON ATKINS CLARK ROAD, LOCATED OFF US HIGHWAY 71, IN SECTIONS 3, 4 AND 5, TOWNSHIP 15 NORTH, RANGE 11 WEST, AND IN SECTIONS 21, 28, 33 AND 34, TOWNSHIP 16 NORTH, RANGE 11 WEST, BOSSIER PARISH, LOUISIANA, AND PROVIDING THE PENALTIES FOR VIOLATION THEREOF.

SECTION 1. BE IT ORDAINED by the Bossier Parish Police Jury in regular and legal session convened on this 19th day of October, 2005, that from and after the effective date of this ordinance, it shall be unlawful for any person to operate or drive a vehicle upon Atkins Clark Road, located off US Highway 71, in Sections 3, 4 and 5, Township 15 North, Range 11 West, and in Sections 21, 28, 33 and 34, Township 16 North, Range 11 West, Bossier Parish, Louisiana, in excess of Thirty-Five (35) miles per hour.

SECTION 2. BE IT FURTHER ORDAINED, etc., that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

The ordinance was offered by Mr. Meachum, seconded by Mr. Cochran. Upon unanimous vote, it was duly adopted on this 19th day of October, 2005.

Mr. Cathcart, Public Works Director, reported that parish crews are working on a parking lot for East Central Bossier Parish Fire District No. 1. He stated that work on the walking trail at Meadowview Elementary School should be complete next week.

Motion was made by Mr. Cochran, seconded by Mr. Altimus, that Mr. Cochran will contribute \$100 from discretionary funds to Plantation Park Elementary School, and will donate approximately \$1,000 from discretionary funds to Bossier High School and Airline High School track teams. Motion carried unanimously.

Mr. Altimus stated that it is recommended by the staff that revenues from slot machine gaming be moved from the General Fund to the Capital Projects Fund for the 2006 budget. He further stated that a 4.1% COLA increase is being considered for 2006.

Motion was made by Mr. Mitchell, seconded by Mr. Avery, to schedule a condemnation hearing on November 2, 2005, to consider condemnation of property at 154 Skipper Drive, Haughton, LA. Motion carried unanimously.

Mr. Avery requested that the owner of property behind Rosedale Subdivision be notified of a property standards violation due to construction debris.

Motion was made by Mr. Williams, seconded by Mr. Mitchell, to schedule a condemnation hearing on November 2, 2005, to consider condemnation of property at 1398 Linton Road. Motion carried unanimously.

Mr. Mitchell discussed the condition of property on Benton Road advising that the owner should be notified that the property is in violation of property standards. Mr. Avery stated that he will get the address of the owner.

Mr. Rogers requested that the owner of property at 139 Lawrence Drive and the owner of the Merrywood Tire Center be advised that the properties are in violation of property standards regulations.

Mr. Cathcart reported that a drainage problem at Doe Ridge and Clear Brook in Forest Hills Subdivision has been corrected.
