1. Applications must be filled out completely and signed by the applicant and the property owner, and fees paid for **all** cases. The application and all required information must be submitted to the commission.
2. Site Plans: **(1 copy - 11" x 17") (SITE PLAN MUST ILLUSTRATE REQUEST)**
 - a. Drawings must have north arrow and scale shown.
 - b. Drawing showing tract with all dimensions.
 - c. All existing (that will remain) and proposed structures with dimensions of front, side, and rear yards.
 - d. Show front setback line.
 - e. All existing or proposed rights-of-way including streets, alleys, and utility easements.
 - f. Dimensions of existing and proposed entrances and exits.
 - g. For sign review show sign dimensions, structure, location & height (both existing and proposed)
3. Vicinity Map: Size **8 1/2" X 11" or 8 1/2" X 14" - one (1) copy**
4. Legal Description
5. Letter of Explanation
6. Any other supplemental documentation as requested.
