MINUTES
September 6, 2017

The Bossier Parish Police Jury met in regular and legal session on the 6th day of September, 2017, at 2:00 p.m., in the Police Jury Meeting Room, Bossier Parish Courthouse, Benton, Louisiana. The President, Mr. Bob Brotherton, called the meeting to order. The invocation was given by Ms. Wanda Bennett, and the pledge of allegiance was led by Mr. Jimmy Cochran. The Parish Secretary, Ms. Rachel Hauser, called the roll, with all members present, as follows:

Others present were Mr. Bill Altimus, Parish Administrator; Mr. Patrick Jackson, Parish Attorney; Mr. Joe E. "Butch" Ford, Jr., Parish Engineer; Ms. Rachel Hauser, Parish Secretary.

Mr. Rocky Rockett, Greater Bossier Economic Development Foundation, presented the 2017 demographic study. He stated that the study provides wage data, population data, and a variety of other data which is useful when selling our community to a variety of different sight selectors. He provided additional information pertaining to collected data.

Mr. Rockett encouraged jurors and the public to visit www.GBEDF.org for additional information. He stated that monthly indicators are now provided on the website so that current information is available to sight selectors in an effort to bring more businesses to our area. He further stated that a variety of useful information is available on their website.

Appreciation was extended to Mr. Rockett for his presentation.

Ms. Vicki Hendrix, 7505 Cottonwood Lane, Haughton, LA, presented a complaint that the owner of the property located behind her home is shooting arrows into her backyard. She stated that she has young grandchildren and pets, and is concerned for their safety, as well as the safety of her neighbors.

Ms. Hendrix stated that complaints have been filed with the Bossier Parish Sheriff's Department, and a Bossier Parish Deputy instructed her neighbor to stop shooting arrows into anyone's yards. She stated that her neighbor continues to shoot arrows into her yard. Ms. Hendrix stated that the Sheriff's Department recommended that she present this issue to the police jury for assistance.

Mr. Jackson asked if restrictive covenants are recorded in the Bossier Parish Clerk of Court's Office for Creekside Subdivision. Ms. Hendrix stated that she is unsure if there are any covenants recorded for the subdivision. After further discussion, Mr. Jackson recommended that he be allowed time to review this matter further and determine if there are any recorded restrictive covenants for Creekside Subdivision which possibly could assist Ms. Hendrix. He stated that this matter could be considered as an attractive nuisance wherein someone is performing a conduct that creates a hazard to a surrounding area. Mr. Jackson stated that there is no parish ordinance which prohibits someone from shooting arrows on their property as that type of ordinance would create unintended consequences.

Mr. Jackson stated that general civil tort law provides an individual standing to sue a neighbor if he or she is doing something that creates a hazard to an individual or their family. He stated that once he has reviewed this matter further, he will provide Ms. Hendrix with additional information.

Mr. Glenn Bullard, Secretary of the Cross Creek Subdivision Homeowners Association, introduced Mr. Marty Bamberg, President, and Mr. Rick Krusemark, Treasurer, of the Cross Creek Subdivision HOA.

Mr. Bullard stated that on behalf of himself and his fellow board members of the Cross Creek Subdivision HOA, they wanted to publicly acknowledge the outstanding service provided to their community by the Bossier Parish Police Jury and their police juror representative for District 6, Mr. Rick Avery. He stated that recently, the HOA reached out to the police jury for guidance and assistance in correcting a reoccurring problem at the intersection of Airline Drive and Regent Street. Mr. Bullard stated that Mr. Avery and Mr. Butch Ford, Parish Engineer, quickly assessed the issue, identified the cause and possible solution, and initiated efforts to correct the issue quickly.

Mr. Bullard stated that the residents of Cross Creek Subdivision appreciate the work done by the police jury. He stated that the police jury has always responded in a timely manner to assist when needed, especially during flooding and after tornadoes damaged portions of Bossier Parish.

Mr. Bullard presented a plaque to Mr. Avery and the police jury expressing appreciation from the Cross Creek Homeowners Association.

Ms. Alan Andersen, 1400 Wafer Road, Haughton, LA, stated that she and her husband previously came before the police jury requesting that the police jury repair damage to their property by Wicker Construction, Inc., when they installed a sewer line between their property and their neighbor. She stated that all photographs of the damage were provided to the police jury at the April 5, 2017, police jury meeting.

Ms. Andersen stated that trees were cut down, but the stumps were never removed, property boundary markers were knocked down and have not been replaced, and large amounts of debris from drainage has caused damage to their culvert. She stated that Wicker did return to their property and implied that the stumps and debris from trees should have been removed and the area should have been graded. She further stated that a representative of Wicker stated that they would return when there has been two consecutive weeks with no rain to remove the stumps and debris and grade the area. Ms. Andersen stated that no one from Wicker has returned to the property since that time.

Ms. Andersen stated that they were instructed not to contact Wicker by Mr. Benton and Mr. Ford, and that the parish would deal directly with Wicker. Mr. Benton stated that he does not recall requesting that the Andersen's not contact Wicker directly.

Mr. Jackson asked Mr. Ford for an update on this matter, and if Wicker is refusing to repair the damage. Mr. Ford stated that Wicker has agreed that they will be responsible for the work, but that it has been too wet to access the property. Ms. Andersen stated that the property has not been too wet as utility companies have been on the property with no difficulties. She stated that Wicker has not returned to their property to determine if the property is too wet to make the repairs.

Mr. Jackson stated that a deadline needs to be set for Wicker to repair the damage, and if it is not done within that time frame, parish crews need to immediately make the repairs and hold Wicker liable for all costs incurred by the police jury for the repairs. Mr. Ford stated that the approximate size of the lot is one to one and a half acre that needs to be cut, bush-hogged and leveled. He stated that Wicker was put on notice in April when the Andersen's came before the police jury that they needed to remove the stumps and debris and grade and level the area.

Mr. Jackson recommended that Wicker be allowed 30 days in which to complete the repairs on the Andersen's property, and if it is not done within that time, the parish will make the repairs and Wicker will be held liable for all costs incurred by the parish for this work.

Ms. Andersen stated that Mr. Ford previously stated that the parish would have the property resurveyed and boundary markers replaced that were knocked down during construction of the project. Mr. Jackson stated that the property needs to be cleaned up prior to a survey being done. Mr. Ford stated that a cost estimate has already been obtained to resurvey the property.

Ms. Andersen stated that at the April 5, 2017, police jury meeting it was recommended that it be determined if the damage to the driveway culvert qualified for funds from the Federal Emergency Management Agency. She stated that the driveway culvert was destroyed due to large debris, including stumps and gravel, being washed into their culvert. She referenced a contract between the Bossier Parish Police Jury and her and Mr. Andersen which states that "grantee hereby agrees and obligates itself to pay for any damages which may occur to property, fences or buildings".

Mr. Jackson stated that this matter will be reviewed in 30 days. Ms. Bennett recommended that Mr. Jackson personally contact Wicker Construction, Inc., to further discuss this matter.

Ms. Lisa Johnson, Bossier Chamber of Commerce, requested that she be allowed to present an update on the BeBossier.com campaign.

Motion was made by Mr. Skaggs, seconded by Mr. Salzer, to amend the agenda to add Ms. Lisa Johnson, Bossier Chamber of Commerce, as a visitor.

The President called for public comment. There being none, **motion carried, with the following vote recorded:**

Ms. Johnson presented the third quarter update on the BeBossier.com campaign for Bossier Parish and the City of Bossier City. She stated that the campaign launched on March 29, 2017, and the social media campaign began shortly thereafter.

Ms. Johnson stated that one of the top website stories is the "Hidden Gems You Won't Want to Miss in Bossier" which covers several different areas in Bossier Parish. She stated that "Is Bossier Safe?" is another top website story. Ms. Johnson stated that crime is a hot topic locally and across the nation.

Ms. Johnson stated that 28.50 percent of website traffic is from the Dallas, Texas, area, and 27.60 percent is from Bossier City. She stated that the next largest website traffic is from the Houston, Texas, area.

Ms. Johnson stated that the following social media profiles were launched in July of 2017: Facebook.com/bebossier, Twitter.com/be_bossier, and Instagram.com/bebossierblog. She provided additional information pertaining to social media profiles.

Ms. Johnson presented the 2017 Annual Manual featuring Pierre Bossier who is the founder of Bossier Parish and instrumental in forming Bossier Parish in 1843. She stated that the Annual Manual is a guide through Bossier City and Bossier Parish for anyone looking to relocate to the area and re-instill the pride in Bossier Parish. She further stated that the Annual Manual can be found at several different locations throughout Bossier Parish.

Appreciation was expressed to Ms. Johnson for their work in Bossier Parish.

Mr. Skaggs stated that on July 5, 2017, the police jury adopted the 2017 property tax millage rates based on last year's millage rates. He stated that since adoption of the 2017 property tax millage rates, the Bossier Parish Assessor's Office submitted new adjusted property tax millage rates which would allow the parish to adopt higher property tax millage rates due to a loss in tax revenue.

Mr. Skaggs reported on a Finance Committee meeting, stating that it is the recommendation of the Finance Committee that the police jury not adopt the new adjusted property tax millage rates as presented by the Bossier Parish Assessor's Office and the 2017 property tax millage rates adopted on July 5, 2017, remain in full force and effect. He stated that no action is required on this agenda item.

Mr. Hauser stated that no action is required on Agenda Item No. 2 as Ordinance No. 4694 adopted on July 5, 2017, will remain in full force and effect to keep the 2017 Property Tax Millage Rates the same as last year.

Ms. Hauser announced the public hearing to consider approval of the plat of the proposed development of Heartwood Acres Subdivision, Unit No. 1, located in Section 20, Township 20 North, Range 12 West, Bossier Parish, LA.

Ms. Sandra Davis, FBL & Associates, Inc., stated that the developer, Mr. Philip Rodgers, is requesting to develop a subdivision on a 40-acre tract of land located off Crouch Road, south of Highway 162. She stated that a total of 35 lots are planned for Heartwood Acres Subdivision, with the lots being three-quarters to one acre in size.

Ms. Davis stated that Unit No. 1 consists of 12 lots. Ms. Bennett asked if the proposed development meets all parish subdivision regulations. Mr. Ford stated that the homes will be stick built, and individual sewer plants, sidewalks and streetlights are planned. He stated that water will be supplied by CBB Water System, Inc.

Mr. Ford stated that a drainage study has been received and reviewed. Mr. Skaggs asked if the proposed development will have interior driveways. Ms. Davis stated that all lot access will be interior driveways.

Mr. Benton stated that there has been previous discussion to require a temporary gravel turnaround at the end of Fannin Drive for garbage trucks and school buses to use until additional units have been developed.

After further discussion, there being no objection, **motion was made by Ms. Bennett, seconded by Mr. Skaggs, to approve the plat of the proposed development of Heartwood Acres Subdivision, Unit No. 1, located in Section 20, Township 20 North, Range 12 West, Bossier Parish, LA, subject to the stipulation that a temporary gravel turnaround will be constructed at the end of Fannin Drive for school buses and garbage trucks.**

The President called for public comment. There being none, **votes were cast and the motion carried unanimously.**

Ms. Hauser announced the hearing to consider the emergency condemnation of property with a physical address of 3191 Jamerson Road, Haughton, LA, Tax Assessment No. 142133, and located on property owned by Ms. Earnestine Johnson and Sapphire Land Co., LLC, Tax Assessment No. 116130.

Mr. Jackson stated that this property has previously been in violation of property standards and health regulations. He stated that the Department of Health recently re-inspected the property for health violations, and it was determined that the property is in violation of health regulations.

Mr. Chip Reeves, Department of Health, stated that a complaint was received on July 28, 2017, of raw sewerage on the ground in the area of 3185 Jamerson Road. He stated that there are approximately four residences existing on the tract of land. Mr. Reeves stated that the mobile home with an address of 3191 Jamerson Road has an illegal septic tank, and presented photographs of the illegal septic tank. He stated that the lid on the tank is not watertight and will therefore take on rainwater, which will cause effluent to run into the ditch when the tank becomes full.

Mr. Reeves stated that a certified letter was sent on August 1, 2017, and signed for on August 2, 2017, by Earnestine Johnson. Mr. Brotherton asked what type of septic tank is located at this home. Mr. Reeves stated that the septic tank has an open-end fill line which is illegal.

Mr. Reeves stated that the August 1, 2017, letter instructed the owner to apply for a permit with the Department of Health within 10 days to replace the illegal system. He stated that he re-inspected the property on August 14, 2017, and there has been no change.

Mr. Donya Johnson, owner of the mobile home located at 3191 Jamerson Road, stated that the existing septic system was installed approximately 25 years ago and should fall under the grandfather law for septic systems. He stated that he moved out of the mobile home approximately six years ago, but kept the utilities on in order to water his horses located on the property.

Mr. Johnson claimed that the woman who submitted the complaint of the illegal sewer system burnt his mother, Ms. Earnestine Johnson's, home down earlier this year which is also located on this tract of land. He stated that he allowed his mother to temporarily live in the mobile home. He further stated that he and his mother financially cannot replace the sewer system, and further stated that he is willing to board the mobile home up and prohibit anyone from living in the mobile home in an effort to resolve this matter. Mr. Johnson stated that he needs the utilities to remain on in order to water his horses, and he is unsure where his mother will live. He stated that he was not aware of this hearing until today because he lives on Arkla Plant Road and did not receive the letter.

Ms. Donna Johnson, 3199 Jamerson Road, stated that she is Mr. Donya Johnson's sister, and lives in the mobile home behind 3191 Jamerson Road. She stated that her mobile home was purchased and set in 1996 and she obtained a permit for her septic system and has all documentation to ensure that her mobile home was placed legally on the property. She further stated that she also assists with providing water to the horses on the property. Ms. Johnson stated that she is present today to ensure that her mobile home is not in violation of any property standards or health regulations.

Mr. Reeves stated that Ms. Donna Johnson's mobile home at 3199 Jamerson Road obtained the required permit for the septic system for her home. Mr. Jackson stated that based on the information provided, the home located at 3199 Jamerson Road is not in violation of any parish regulations.

Ms. Sonya Jamerson stated that the septic system at 3191 Jamerson Road was installed approximately 25 years ago, and the laws pertaining to septic systems were not put in place until 1995. She further stated that the complaints being submitted to the Department of Health is by a woman who is a wanted criminal.

Mr. Jackson stated that it is irrelevant who submitted a complaint, but whether the complaint is valid. He stated that the existing septic system at 3191 Jameson Road is not in compliance with health regulations and must be replaced in order for the home at 3191 Jamerson Road to be inhabited. Ms. Jamerson asked if the septic system was illegal 25 years ago. Mr. Reeves stated that he has been with the Department of Health for a little over 25 years, and the Department of Health has never permitted a septic tank made from a plastic culvert with a discharge to the road ditch.

Mr. Jackson stated that it is possible that the septic system was installed without a permit during a time when the utility departments turned on utilities without notifying the parish. He stated that utility departments now notify the parish to ensure that all regulations have been met prior to utilities being turned on. Mr. Jackson stated that the parish has

been made aware of the non-compliant septic system, and a compliant septic system must be installed for the mobile home to be inhabited.

Ms. Earnestine Johnson, owner of the tract of land in which the mobile home at 3191 Jamerson Road is located, stated that her home located at 3185 Jamerson Road was the original home located on this tract of land. She stated that in the 1970's there were no restrictions for installation of septic systems. She further stated that she is not financially able to purchase a new septic system for the mobile home. Ms. Johnson stated that the government or state should assist her with cleaning her property and bringing her property into compliance with all regulations.

Mr. Jackson stated that the Parish of Bossier has an obligation to notify every person or entity that has an interest in a piece of property. He stated that an illegal septic system exists on Ms. Earnestine Johnson's property which poses a danger to the public and no one can live in the structure owned by Mr. Donya Johnson located on her property without a sanitary septic system. Mr. Jackson stated that in order to resolve this matter the family can (1) request a certain amount of time to bring the septic system into compliance with parish and health regulations, (2) assure that the home will remain uninhabited until a sanitary septic system can be installed, or (3) if the family is unable to adhere to one of the two options above, in order to protect the public the parish will bring a lawsuit to condemn the property which would prohibit anyone from living in the home until a sanitary septic system can be installed.

Mr. Donya Johnson stated that he will not allow anyone to live in the home in order to resolve this matter and will cover the septic system. He stated that his mother will have to make other arrangements for a home.

Mr. Reeves stated that there are federal grants and loans available to assist someone in a matter of this nature, but it is a lengthy process.

Mr. Jackson stated that the property will be re-inspected in two weeks, and requested that the property owners receive notice that this matter will be tabled until the September 20, 2017, regular meeting for review.

Mr. Altimus reported that CSRA has obtained contracts to assist with the recent catastrophes which will increase available jobs at the call center by 200 to 300 jobs.

Mr. Altimus reported on a conference call with the Governor’s Office of Homeland Security and Emergency Preparedness pertaining to decisions that the state needs to make depending on the direction taken by the current hurricane.

Mr. Mark Coutee, Public Works Director, presented an update on activities of the highway department and on several road projects in the parish.

Ms. Bennett reported that in 1948 a creosote plant existed in Benton, LA, that provided several types of wood. She stated that the plant closed in 2008 and the land could not be used. Ms. Bennett referred to a recent article in the

Bossier Press Tribune regarding the creosote plant, and stated that there are plans to clean the property which will allow the land to be utilized in the future.

There being no further business to come before the Bossier Parish Police Jury in regular and legal session on this 6th day of September, 2017, the meeting was adjourned by the President at 3:37 p.m.
