The Bossier Parish Police Jury met in regular and legal session on the 20th day of October, 2021, at 2:00 p.m., in the Police Jury Meeting Room, Bossier Parish Courthouse, Benton, Louisiana. The President, Mr. Jerome Darby, called the meeting to order. The invocation was given by Mr. Tom Salzer, and the pledge of allegiance was led by Mr. Doug Rimmer. Ms. Rachel Hauser, Parish Secretary, called the roll, with all members present as follows:

Ms. Hauser announced the public hearing to consider approval of the Site Plan for Swan Lake Commercial Subdivision, Unit No. 2, being a resubdivision of Swan Lake Commercial Subdivision, Unit No. 1, located in Section 26, Township 19 North, Range 13 West, Bossier Parish, LA (Located on the corner of Swan Lake Road and Duckwater Landing). This matter was tabled on October 6, 2021. She stated that it has been requested that the public hearing on this matter be tabled to the November 3, 2021, regular meeting.

Motion was made by Ms. Parks, seconded by Mr. Rodgers, to table the public hearing to consider approval of the Site Plan for Swan Lake Commercial Subdivision, Unit No. 2, being a resubdivision of Swan Lake Commercial Subdivision, Unit No. 1, located in Section 26, Township 19 North, Range 13 West, Bossier Parish, LA (Located on the corner of Swan Lake Road and Duckwater Landing), to be considered at the November 3, 2021, regular meeting.

Votes were cast, and the motion carried unanimously.

Ms. Hauser announced the public hearing to consider approval of the plat of the proposed development of Edgewater Pass Subdivision, located in Section 22, Township 19 North, Range 13 West, Bossier Parish, LA. (Located off Legacy Elementary Drive)

Mr. Donnie Barker, Mohr and Associates, Inc., was present on behalf of the developer. Mr. Hudson stated that all drainage issues have not been resolved for this development and he cannot recommend approval of the proposed plat at this time

Mr. Erik Adams, 2389 Tallgrass Circle, Bossier City, LA, was present. He presented safety concerns in the Legacy Subdivision area due to Sawgrass Parkway having no sidewalks for students to walk to school and residents walking to access amenities for the subdivision. He provided information from the Bossier City-Parish Metropolitan Planning Commission meetings and Bossier Parish Police Jury meetings in connection with the construction of Sawgrass Parkway and requirements that were put in place by each entity.

Mr. Adams requested that the police jury deny, table, or return the proposed Edgewater Pass Subdivision back to the Bossier City-Parish Metropolitan Planning Commission pending completion of sidewalks as required by Bossier Parish Police Jury regulations. He also requested that no further development by LP Development, LLC, be allowed in Legacy Subdivision until they have complied with all parish subdivision regulations.

There was extensive discussion on sidewalks in Legacy Subdivision and Sawgrass Parkway, and discussions that were held with the Bossier Parish School Board pertaining to student access to Legacy Elementary School.

Ms. Amanda Jones, 3114 Sabine Pass Drive, Bossier City, LA, stated that the Bossier Parish School Board does not provide any type of permission form which states that a child has permission to walk to and from school. She stated that the school board website encourages students to walk and/or ride their bikes to and from school as long as they are accompanied by a parent.

There was additional discussion on sidewalks in Legacy Subdivision.

Mr. Barker stated that the approved masterplan for this development does not provide for sidewalks on Sawgrass Parkway. He provided additional information on sidewalks in Legacy Subdivision. He stated that in discussions with the Bossier Parish School Board, the school board preferred that students enter Legacy Elementary from the front of the school.

Ms. Parks stated that she does not feel any further development in Legacy Subdivision should be allowed until all issues concerning sidewalks have been resolved, and stated that a sidewalk should be located along Sawgrass Parkway.

After further discussion, motion was made by Ms. Parks, seconded by Mr. Rimmer, to table the public hearing to consider approval of the plat of the proposed development of Edgewater Pass Subdivision, located in Section 22, Township 19 North, Range 13 West, Bossier Parish, LA (Located off Legacy Elementary Drive), to be considered at the November 3, 2021, regular meeting.

Votes were cast, and the motion carried unanimously.

Motion was made by Mr. Plummer, seconded by Mr. Salzer, to schedule a public hearing on December 1, 2021, to consider adoption of the 2022 Bossier Parish Police Jury Budget.

The President called for public comment. There being none, votes were cast, and the motion carried unanimously.

Motion was made by Mr. Rimmer, seconded by Mr. Cochran, to schedule a public hearing on November 17, 2021, to consider adoption of an ordinance amending Chapter 94, "Commercial Vehicle Enforcement",

Section 94-10(B)(8), of the Bossier Parish Code of Ordinances, to add subsection (K) Establishing Additional BPPJCVEU Permit Conditions and Fees.

The President called for public comment. Mr. Jackson stated that companies obtaining permits scheduling rig moves are not showing up at the designated time which leaves CVEU officers waiting at the site for hours. He stated that the proposed amendment provides that a \$250.00 per hour fee will be assessed each hour exceeding two hours after the scheduled rig move time.

Votes were cast, and the motion carried unanimously.

Motion was made by Mr. Jorden, seconded by Mr. Brotherton, to schedule a public hearing on November 17, 2021, to consider approval of the Minor Plat for Grant Dunlap, located in Section 16, Township 18 North, Range 11 West, Bossier Parish, LA. (Located off Evangeline Lane off Highway 3227)

The President called for public comment. There being none, votes were cast, and the motion carried unanimously.

Motion was made by Mr. Jorden, seconded by Mr. Gray, to schedule a public hearing on November 17, 2021, to consider approval of the proposed development of South Haughton Estates Subdivision, Unit No. 2, located in Section 35, Township 18 North, Range 11 West, Bossier Parish, LA. (Located on Hickory Nut Lane off Camp Zion Road in South Haughton Estates Subdivision)

The President called for public comment. There being none, votes were cast, and the motion carried unanimously.

Motion was made by Mr. Brotherton, seconded by Mr. Jorden, to schedule a public hearing on December 1, 2021, to consider the application of Freddie M. Widmer to the Bossier City-Parish Metropolitan Planning Commission for a zoning amendment to change the zoning classification of a certain tract of land being 9.992 acres, more or less, located at 3475 Sligo Road, Bossier City, LA, in Section 13, Township 17 North, Range 12 West, Bossier Parish, LA, from I-1, Light Industrial District, to R-A, Residence-Agricultural District, for personal storage.

The President called for public comment. There being none, votes were cast, and the motion carried unanimously.

Mr. Ghormley reported on a meeting of the Property Standards Board of Review, advising that it is recommended that a condemnation hearing be scheduled on November 3, 2021, to consider condemnation of property located at 3402 Pinehaven Circle, Haughton, LA, Tax Assessment No. 103329.

Mr. Pat Culverhouse, Ms. Monica Grappe, Mr. Sam Marsiglia, Mr. Mark Coutee, Mr. Ford, Mr. Jackson, Ms. Julie Gill, Mr. Heath Lyles, Mr. Hudson, Mr. Altimus, Mr. Larry Landry, Ms. Fernandez, Ms. Lisa Wilson, Mr. Jim Firth, Mr. Warren Saucier, Mr. Nguyen Kha, Mr. Jason Weinland, and Ms. Hauser were also present. Mr. Jackson stated that approximately 10 years ago, the police jury and the Louisiana Oil and Gas Association (LOGA) worked together to create a comprehensive noise ordinance that primarily was modeled from the City of Forth Worth, Texas's, ordinance and their experience with the Barnett Shale.

Mr. Jackson stated that recently, Bossier Parish experienced its first urban type fracking operation in southern Bossier Parish. He stated that the oil and gas company conducting the fracking operation worked diligently to comply with all parish regulations sparing no expense to remain in compliance. He further stated that unfortunately after all efforts being made by the oil and gas company, they have been unable to remain in compliance with certain portions of parish regulations, especially during late night hours.

Mr. Jackson stated that after discussions with parish staff regarding this matter, it has been determined that parish regulations that were put in place over 10 years ago pertaining to oil and gas operations needs to be amended.

Mr. Jackson stated that the recommendation being made today is that the police jury consider placing a 60-day moratorium on frac operations within 3,000 feet of a platted subdivision located inside the Bossier City-Parish Metropolitan Planning Commission, Benton-Parish Metropolitan Planning Commission, and Haughton Metropolitan Planning Commission areas between the hours of 10:00 p.m. and 7:00 a.m.

Mr. Jackson stated that current parish regulations prohibit workover operations between the hours of 10:00 p.m. and 7:00 a.m. He recommended that fracking operations be included to current parish regulations to prohibit operations between the hours of 10:00 p.m. and 7:00 a.m.

Mr. Jackson stated that before any amendments are made, meetings need to be scheduled with partners in the oil and gas industries to discuss proposed amendments to parish regulations as it relates to oil and gas operations in Bossier Parish to reach an amicable resolution to noise issues.

Mr. Hudson stated that the parish has received numerous complaints of excessive noise due to fracking operations near residential subdivisions. He stated that noise studies are required from oil and gas companies at their

Ms. Carlotta Askew-Brown, Bossier City-Parish MPC and Benton Parish MPC, stated that the City of Bossier City and the Town of Benton are experiencing similar noise issues and will be reviewing their current regulations as it pertains to noise from oil and gas company well sites.

Mr. Steven Robert, 418 Baylynn Lane, Benton, LA, asked what actions will be taken during a 60-day moratorium on frac operations. Mr. Jackson stated that the intent during the proposed 60-day moratorium on frac operations between the hours of 10:00 p.m. and 7:00 a.m. is to schedule meetings with representatives from the oil and gas companies in order to allow them to offer suggestions for changes in parish noise regulations. He stated that the parish will need to consider retaining the services of a professional to assist the parish with noise regulations due to the lack of available employees to assist with enforcement of parish noise regulations. He further stated that it is the intent of the parish to work with oil and gas companies to reach an amicable resolution to noise issues in the Parish of Bossier.

Motion was made by Mr. Rimmer, seconded by Mr. Plummer, to place a 60-day moratorium on all frac operations within 3,000 feet of a platted subdivision located inside the Bossier City-Parish Metropolitan Planning Commission, Benton-Parish Metropolitan Planning Commission, and Haughton Metropolitan Planning Commission areas between the hours of 10:00 p.m. and 7:00 a.m.

The President called for public comment. Mr. Robert Kyle, 350 Hunters Hollow Drive, Bossier City, LA, asked if the parish is voting to stop all fracking operations between the hours of 10:00 p.m. and 7:00 a.m. indefinitely or if this will be for 60 days only. Mr. Jackson stated that what is being considered today is a 60-day moratorium on fracking operations during the hours of 10:00 p.m. and 7:00 a.m. only. He stated that if the parish and representatives of the oil and gas companies can reach an amicable resolution prior to 60 days, the moratorium could be lifted.

Mr. Benton asked if this moratorium could be in effect for all subdivisions in Bossier Parish and not be limited to those located inside the metropolitan planning commissions. Mr. Jackson stated that a parishwide moratorium was considered, but after further discussions the recommendation at that time was for the moratorium to affect subdivisions located inside the metropolitan planning commissions. He stated that current regulations for noise is parishwide.

Mr. Jackson stated that the Parish of Bossier welcomes oil and gas operations in Bossier Parish and will work closely with those companies to reach an amicable resolution.

Votes were cast, and the motion carried unanimously.
