The Bossier Parish Police Jury met in regular and legal session on the 7<sup>th</sup> day of June, 2023, at 2:00 p.m., in the Police Jury Meeting Room, Bossier Parish Courthouse, Benton, Louisiana. The President, Mr. Doug Rimmer, called the meeting to order. The invocation was given by Mr. Charles Gray, and the pledge of allegiance was led by Mr. Mac Plummer. **Motion was made by Mr. Plummer, seconded by Mr. Gray, to adopt the minutes of the April 5, 2023, and April 19, 2023, regular meetings, and the April 19, 2023, Finance Committee meeting, as published.**

The President called for public comment. There being none, **votes were cast and the motion carried unanimously.**

Mr. Rimmer asked if anyone was present that would like to address the police jury to discuss an item that is currently not on the agenda. No one was present.

Mr. Jim Firth, Purchasing Agent, introduced Ms. Dana Wood, Senior Vice President of Risk Services of Louisiana, Inc. He stated that Ms. Wood has been the police jury's worker's compensation agent for approximately 25 years.

Ms. Wood introduced her daughter, Ms. Lauren Wood, and advised that she also works on the police jury's account. She stated that the Bossier Parish Police Jury was placed with Louisiana Worker's Compensation Corporation in 2003 and the police jury has been very successful and has a great safety record. She further stated that dividends in the amount of over \$1.6 million have been paid by LWCC to the police jury which amounts to seven years of premiums.

Ms. Wood stated that the police jury is being presented with the LWCC Safest 70 Award. Mr. Damian Simoneaux, Safety Manager for LWCC, stated that LWCC tries to recognize policy holders that cooperate, show initiative, and promote a safe working environment. He stated that they review over 21,000 policy holders and out of those policy holders, 70 are selected for the award.

Mr. Simoneaux presented the police jury with the LWCC Safest 70 Award for 2022. He presented a letter from the CEO of LWCC which reflects what LWCC thinks about the award and why the award is presented to the policy holders.

Ms. Hauser announced the public meeting to adopt property tax millage rates for the year 2023. The jury concurred that the Bossier Parish Police Jury will not adopt the adjusted max millage rates allowed due to inflation and will not roll forward its property tax millage rates for the year 2023. The jury concurred that the Bossier Parish Police Jury will adopt the same tax millage rates that are currently in place. **Motion was made by Mr. Benton, seconded by Mr. Rodgers, to adopt an ordinance levying the 2023 property tax millage rates for the General Alimony Tax, Highway Tax, Library Tax, Health Unit Tax and Corrections Facilities Tax.**

ORDINANCE NO. 4957

AN ORDINANCE PROVIDING FOR THE LEVY OF A USER FEE OF \$36.00 PER YEAR (MILL KEY #1026053) FOR THE PURPOSE OF PAYING THE COSTS OF ANY AND ALL EMERGENCY MEDICAL TRANSPORTATION AND ALL EMERGENCY SERVICES IN THE BOSSIER PARISH EMERGENCY MEDICAL SERVICE DISTRICT, PARISH OF BOSSIER, STATE OF LOUISIANA, FOR THE YEAR 2023, IN ACCORDANCE WITH THE LAW.

SECTION 1. BE IT ORDAINED by the Bossier Parish Police Jury, acting as the governing authority of the Bossier Parish Emergency Medical Service District, in regular and legal session on the 7<sup>th</sup> day of June, 2023, that in accordance with law, a user fee of \$36.00 per year for the year 2023, shall be assessed persons owning each residential or commercial structure either occupied or unoccupied, located wholly or partly within the boundaries of the said District, each residential or commercial structure being defined as each residential or commercial unit in a structure and each housing unit within a multiple structure, and a mobile home, as defined in R. S. 9:1149.s(3), for the purpose of paying the costs of any and all emergency medical transportation and all emergency services incidental thereto, as authorized and approved at a special election held in said District on October 16, 1993.

SECTION 2. BE IT FURTHER ORDAINED, etc., that the proper administrative officers of the Parish of Bossier, State of Louisiana, be and they are hereby empowered, authorized and directed to extend said user fee against assessment roll of said District for the year 2023, and to make the collection of the user fee imposed for and on behalf of said District, according to law, and that the user fee herein levied shall become a permanent lien and privilege on all property subject to said user fee as set forth by law, and the collection shall be enforceable in the manner provided by law.

ORDINANCE NO. 4958

AN ORDINANCE TO LEVY AN ACREAGE TAX (MILL KEY #1026043) OF EIGHT CENTS PER ACRE ON ALL FOREST LANDS AND CUT-OVER POTENTIAL FOREST LANDS, SITUATED IN BOSSIER PARISH, LOUISIANA, AND TO AUTHORIZE AND DIRECT THE ASSESSOR IN AND FOR BOSSIER PARISH, LOUISIANA, TO ASSESS AND EXTEND SAID TAX ON THE TAX ROLL, AND TO AUTHORIZE AND DIRECT TAX TO BE COLLECTED BY THE SHERIFF AND EX-OFFICIO TAX COLLECTOR IN AND FOR BOSSIER PARISH, LOUISIANA, AND AUTHORIZE THE EXPENDITURE OF SAID FUNDS COLLECTED, ALL ACCORDING TO LAW.

SECTION 1. BE IT ORDAINED by the Police Jury of Bossier Parish in regular and legal session on the 7<sup>th</sup> day of June, 2023, that for the year 2023 there shall be levied on acreage a tax of eight cents per acre on all forest lands and cut-over potential forest lands situated in Bossier Parish, Louisiana.

SECTION 2. BE IT FURTHER ORDAINED, etc., that this acreage tax shall be assessed and extended on the tax roll of Bossier Parish, Louisiana, by the Parish Assessor in the same manner as the assessment and extension on the tax rolls of the other taxes.

SECTION 3. BE IT FURTHER ORDAINED, etc., that said acreage tax shall be collected by the Sheriff and Ex-Officio Tax Collector of Bossier Parish, Louisiana, in the same manner as other parish taxes and when so collected shall be remitted to the Department of the Government having jurisdiction over the practice of forestry for deposit into the State Forestry Fund.

SECTION 4. BE IT FURTHER ORDAINED, etc., that said acreage tax shall be collected and deposited all in accordance with the law.

Ms. Hauser announced the public hearing to consider abandonment of Lots 9-15, 16A, and 16B, J.E. Burt, Jr., Subdivision, located in Section 32, Township 20 North, Range 13 West, Bossier Parish, LA; located off Palmetto Road. This matter was tabled on May 18, 2023.

Mr. Hudson stated that at the May 18, 2023, public hearing to consider abandonment of Lots 9-15, 16A, and 16B, J.E. Burt, Jr., Subdivision there were concerns regarding notification to lot owners in J.E. Burt, Jr., Subdivision and other surrounding subdivisions of this abandonment request. He stated that J.E. Burt, Jr., Subdivision was created many years ago with the original subdivision being 20 lots.

Mr. Hudson stated that there was a subsequent refile of Lots 1-8, J.E. Burt, Jr., Subdivision, which placed these lots into a different subdivision creating two different subdivisions, J.E. Burt, Jr., Subdivision, and James E. Burt, Jr., Subdivision. He stated that Lots 1-8 are considered to be in a different subdivision than Lots 9-20.

Mr. Hudson stated that a second, third, and fourth subsequent filing was done over the years. He stated that Lots 9-20 are located in the J.E. Burt, Jr., Subdivision, and the owner of the lots has submitted a petition signed by all lot owners in J.E. Burt, Jr., Subdivision stating that they have no objection to abandonment of Lots 9-15, 16A, and 16B. Mr. Hudson recommended approval of the requested abandonment due to the owner having complied with parish regulations to abandon lots in a subdivision.

Mr. Salzer asked if 100 percent of all homeowners in J.E. Burt, Jr., Subdivision have signed the petition. Mr. Hudson stated that 100 percent of all homeowners in J.E. Burt, Jr., Subdivision have signed the petition. Mr. Salzer asked for the name of the subdivision located adjacent to J.E. Burt, Jr., Subdivision. Mr. Hudson stated that the subdivision located adjacent to J.E. Burt, Jr., Subdivision is James E. Burt, Jr., Subdivision. He requested that the record reflect that if Lots 1-8 that were refiled and placed in the James E. Burt, Jr., Subdivision, are ever presented for abandonment, a petition from lot owners in the first, second, and third filings of the James E. Burt, Jr., Subdivision will be required.

Mr. Benton asked if there are any homes built on Lots 1-8. Mr. Hudson stated that there are homes built on Lots 1-8, but they are not located in the J.E. Burt, Jr., Subdivision that is the subject of the public hearing today requesting abandonment of Lots 9-15, 16A, and 16B, J.E. Burt, Jr., Subdivision. Mr. Hudson stated that these subdivisions have different covenants.

Mr. Hudson stated that zoning for Lots 9-15, 16A, and 16B vary with some being zoned R-1 and some being zoned B-3. He stated that if the police jury approves the request to abandon Lots 9-15, 16A, and 16B, J. E. Burt, Jr., Subdivision, prior to any development, the owner would be required to rezone the tract of land and submit a plat and site plan to the police jury for consideration.

Mr. Rodgers asked if there are any existing homes on Lots 9-15, 16A, and 16B, J. E. Burt, Jr., Subdivision. Mr. Hudson stated that there are no existing homes on these lots. It was verified that no lots that back up to the lots with existing homes are being abandoned.

There being no objection, **motion was made by Mr. Rodgers, seconded by Mr. Jorden, to approve abandonment of Lots 9-15, 16A, and 16B, J.E. Burt, Jr., Subdivision located in Section 32, Township 20 North, Range 13 West, Bossier Parish, LA; located off Palmetto Road.** The President called for public comment. Mr. David Kalnasy, Jr., property owner, was present. There was discussion of a possible business being run from a location near Mr. Kalnasy's property. Mr. Kalnasy stated that he is unaware of any business being run near this property.

He stated that the rental chillers arrived Friday at approximately 11:00 p.m. along with a 750kw generator and tied them into the existing chiller plant piping.

Mr. Lyles provided information on how the rental chillers and generator were connected to the courthouse and stated that should any of the chillers fail, the back-up chillers will be turned on immediately to continue to cool the courthouse. He stated that purchase orders have been issued for the needed equipment to repair the courthouse chillers and once the equipment has been repaired, the rental chillers and generator will be returned.

Mr. Lyles stated that the 250-ton air cooled chiller that was installed as an emergency back up will be removed and a combination of 500 tons will be installed to replace the 250-ton chiller so that there is true 100 percent redundancy for the courthouse building.

Mr. Salzer recommended that once the cost for all the work needed for the courthouse HVAC system has been determined, a Building and Grounds Committee meeting will need to be scheduled to discuss this matter further.
